The Rostrevor Old Collegians' Association (ROCA) Scholarship

ROCA extends the interests of the College by offering an exclusive network and community connection for old scholars of like mind, through engagement and spirit – for life! This connection with old scholars allows for personal growth and lifelong relationships as a “man for others”.

ROCA Scholarships exists to provide opportunities for the sons and grandsons of Old Collegians to attend Rostrevor, whose family might not otherwise have the financial means to support them in doing so. Applications from students who are not the son or grandson of an Old Collegian, and who may not have the financial means to attend Rostrevor without assistance, are also welcome to apply. Through the thriving Rostrevor Old Collegian network, this Scholarship reflects the College's values of a strong focus on community and remaining connected for life.

Selection Criteria	<p>This Scholarship is awarded at ROCA's discretion to a new/existing student at the College entering Year 7 and/or Year 10 who:</p> <ul style="list-style-type: none"> • Is the son and/or grandson of an Old Collegian wishing to enrol at the College or; • Would otherwise, for extrinsic reasons, be unable to attend the College. <p>In all cases, successful applicants will demonstrate that they will respect the Edmund Rice Education Australia (EREA) Touchstones of Liberating Education, Gospel Spirituality, Inclusive Community and Justice and Solidarity underpinning the College as a Catholic School in the Edmund Rice Tradition. Successful applicants will have the capacity to conduct themselves in a positive manner, presenting as an outstanding ambassador for the College, their family, community and ROCA.</p> <p>Candidates will be shortlisted and interviewed by a committee comprising of the Head of School, Director of Teaching & Learning and Rostrevor Old Collegians' Association (ROCA) President (or delegate). Recommendations will be made to the Principal before student(s) are selected as the successful Scholarship recipient(s). The size and type of scholarship awarded are solely determined at ROCA's discretion.</p>
Benefits	<p>The ROCA Scholarship contribution may range from a minimum of 25% to a maximum of 100% of tuition fees only for years 7-9 or years 10-12.</p>
Expectations	<p>Recipients of a ROCA Scholarship at the College are required to meet all other charges related to a student's education at the College. They include the balance of tuition fees, stationery, uniforms (including Co-Curricular uniforms) and the additional costs if the recipient chooses to participate in optional activities. Please note that this scholarship does not provide remission of boarding fees.</p> <p>The prospective student and his family are required to respect the values underlying a Catholic School in the Edmund Rice Tradition. Students awarded the ROCA Scholarship are expected to fully participate to the best of their ability in the academic life of the College and be willing to contribute widely to the College's Co-Curricular Program. It is also expected that the student will become a life member of ROCA upon graduation.</p>

 - If applicable, the student's relationship to an Old Collegian, at any level.
 - The student's commitment to upholding the EREA touchstones and intention to participate in College life.
 - How the student intends to contribute to the College community and Co-Curricular Program.
 - How the student intends to contribute to ROCA as a student and after graduation.

(Please note that successful applicants are expected to make every effort to act upon any points they outline).

- ☐ Evidence of the student's recent academic performance, including their most recent end of year reports for all subjects. Evidence of NAPLAN results and/or any awards is also encouraged.
- ☐ Evidence of the student's service to, or involvement in, their current community if applicable.
- ☐ Evidence of the student's Co-Curricular involvement and/or achievements if applicable.

Please confirm you meet the prerequisites for consideration for this scholarship opportunity:

- ☐ The applicant is an Australian Citizen and/or Permanent Resident.
- ☐ The applicant will be a day or boarding student in Year 7 or 10, 2027 and have submitted an Enrolment Application Form at Rostrevor College.
